ENVIRONMENTAL POLICY STATEMENT

To identify all reasonably foreseeable environmental risks and hazards associated with our activities in order to eliminate the threat of contamination to the environment.

Where elimination is impossible, to introduce methods of monitoring and control.

Stakeholder Involvement; provide clear and open environmental information about our services and operations to customers, shareholders, employee's, government agencies and the general public.

Inform suppliers of products and services of our environmental requirements and encourage them to adopt sound environmental practices.

Foster environmental responsibility amongst our staff, particularly the management and reduction in the use of natural resources.

We, as a company, will actively seek to make this policy relevant to our activities, and will bring these aims and objectives to the attention of all our employees.

We are committed to seeing this policy work effectively with the intention of continually improving our environmental performance, and will implement a system of monitoring and auditing to check our progress.

As the person ultimately responsible for the environmental issues within the business I am responsible for making this policy work and for encouraging all employees to understand and operate within the framework of the policy. A copy of the policy will be displayed on all relevant notice boards around the business and within the vehicle folders.
